Please consider joining us at **The 4<sup>th</sup> Phoenix Heritage Mineral Show**, sponsored by the Mineralogical Society of Arizona (MSA) on June 1-2, 2024 at The Phoenix Shrine Auditorium. The numerous mineral collectors and visitors who enjoy viewing beautiful exhibits will appreciate your participation in the Show. We expect your exhibit(s) will add greatly to helping make The Phoenix Heritage Mineral Show THE Premier Quality Mineral Show in Phoenix Area!

The 4<sup>th</sup> Phoenix Heritage Mineral Show theme for 2024 is **FLUORITE**. We hope your guest exhibit will be able to highlight the show theme but this is certainly not a requirement. The Show Committee is sponsoring two **"Best of Theme Trophies"** for fluorite in two size categories, Thumbnails to Miniatures and Small Cabinet to Cabinet size specimens. A plaque will be provided for one specimen in each size category. Measurements defining the sizes are provided on the entry form.

The MSA Show Committee is proud to announce awards honoring three Arizonans who have contributed to mineralogy and the collecting hobby, in Arizona, the United States, and the world. All three trophies will include a cash award as well.

1. The **Bob Jones Trophy** is for the **"Best Case of Minerals in the Show,"** entered in this competition, with the emphasis on quality and aesthetics of the specimens. Bob Jones is a renowned author and lecturer, MSA Past President and Life Member having spent his 70 years in Arizona writing about and promoting the mineral collecting hobby. Dana and Brenda Slaughter are sponsoring this trophy. Monetary awards sponsored by MSA and Patrons.
2. The **David Shannon Memorial Trophy** will be awarded to the **"Best Case of Personally Field Collected Specimens,"** entered in this competition. David Shannon dealt in rare species as well as fine specimens, many of which he personally collected. This trophy and monetary awards are sponsored by the Michael Shannon and Joseph Philpott, Jr. families.
3. The **Arthur L. Flagg Memorial Trophy** will be awarded to the **"Best Junior Age Mineral Exhibit Entered in Competition."** Arthur L. Flagg was known as "Mr. Rockhound" in Arizona and was one of the founders and first President of MSA. MSA is sponsoring this trophy. Dana and Brenda Slaughter, MSA and Chris Whitney-Smith are sponsoring monetary awards.

Any exhibits placed as a Guest Exhibit shall not be judged for these awards or Best of Theme trophies.

All exhibitors shall submit a signed Competitive Exhibitor Application.

The various forms are included to enable you to exhibit. If you need any additional information, please write, or contact me directly. Once your exhibit is accepted you will receive information regarding the interior dimensions for liners for the case that has been assigned to you.

The MSA and the Flagg Mineral Foundation (FMF) are providing newly designed and fabricated cases encompassing LED lighting and large glass fronts in two sizes, 30" and 48" wide. There will be 16 to 18, 48" cases and 6, 30" cases. Important items to note are as follows:


- Priority for the cases will be given to the competitive entries and everyone will be assigned based on when your application is received.

**SPECIAL TROPHY COMPETITIONS**

**Rules of the Special Trophy Competitions**

1. These competitions are open to any individual/couple—not to institutions, clubs, groups, businesses or partnerships. The exhibitor(s) shall be the owner of the specimens shown.
2. Specimens shall be labeled correctly with name and location.
3. The only criterion for judging is the quality of the specimen(s). There will be no point score given and the decision of the judges shall be final.
4. **Best of Theme** shall have two size categories, and each exhibitor is eligible to enter one specimen in each category.
  - a. Thumbnail to Miniature, specimen shall be larger than a micromount but fit in a 2” cube.
  - b. Small Cabinet to Cabinet, larger than a miniature to a maximum size of 10” in the largest dimension.
5. **Repaired and Disallowed Specimens.**
  - A. Repaired specimens shall be allowed only under the following circumstances:
    - i. The repair shall be of a crystal glued back together or back onto the matrix.
    - ii. The label shall note the specimen is repaired.
  - B. Disallowed or out-of-class specimens.
    - i. Synthetic, reconstituted, or oiled specimens.
    - ii. Minerals/Specimens embedded in plastic.
    - iii. Cracks have been filled with any type of material.
    - iv. Matrix that has been added to or altered.
    - v. Repairs not noted on the label.
    - vi. Micromounts are allowed only in micromount exhibits.
    - vii. Minerals pressed into a base to meet size requirements.

**Special Trophy Rules**

**BOB JONES TROPHY**

1. A minimum of twelve (12) specimens are required.
2. If any specimens are disallowed or ruled out-of-class and reduce the number of eligible specimens below twelve (12), the exhibit shall be removed from consideration for this trophy.
3. MSA/FMF cases (30" or 48" size) shall be used in this competition. Exhibitors shall provide their own case liners and risers.
4. No individual can win the trophy more than once every three years.

**DAVID SHANNON MEMORIAL TROPHY COMPETITION**

1. A minimum of twelve (12) specimens are required.
2. All specimens shall have personally field collected by the exhibitor.
3. If any specimens are disallowed or ruled out-of-class and reduce the number of eligible specimens below twelve (12), the exhibit shall be removed from consideration for this trophy.
4. MSA/FMF cases (30" or 48" size) shall be used in this competition. Exhibitors shall provide their own case liners and risers.
5. No individual can win the trophy more than once every three years.

**ARTHUR L. FLAGG MEMORIAL TROPHY**

1. This competition is open only to junior-age exhibitors (those who have not turned 18 by the opening day of the show).
2. This trophy shall be presented to the best case of minerals entered by a junior age exhibitor.
3. Rules and categories shall be determined by the TGMS Competitive Exhibitors Handbook.
4. No individual can win the trophy more than once every three years.
